What is the Law Enforcement Torch Run®?

The Law Enforcement Torch Run (LETR) for Special Olympics is the largest grass-roots fundraiser and public awareness vehicle in the world. The annual Torch Run and its various fundraising projects have two goals: to raise money and to gain awareness for the athletes who participate in Special Olympics. At its most basic level, the LETR is a running event in which officers and athletes carry the Flame of Hope™ to the Opening Ceremony of Special Olympics local competitions and State Games. Overall, the LETR initiative encompasses a variety of fundraising vehicles. The LETR in Iowa hosts a variety of special events like Polar Plunge®, Cop on Top, Tip a Cop, Truck Convoy, Plane Pull and much more.

History of the Law Enforcement Torch Run®

LETR began in 1981 when Wichita, Kansas Police Chief Richard LaMunyon saw an urgent need to raise funds for and increase awareness of Special Olympics. The LETR was quickly endorsed by Special Olympics, Inc. and the International Chiefs of Police (IACP), now recognized as the Founding Law Enforcement Organization of the Law Enforcement Torch Run for Special Olympics. More than 96,000 law enforcement in all 50 U.S. States, 12 Canadian provinces/territories, and 44 other countries contribute to LETR efforts annually as Guardians of the Flame®, ensuring the delivery of the Special Olympics Flame of Hope™ to the Opening Ceremonies of local Special Olympics competitions, state/provincial Games, and national/regional Games.

LETR began in 1987 in Iowa and has evolved into the largest grass-roots fundraiser for Special Olympics Iowa. The highly emotional Final Leg of the run involves officers statewide converging on Hilton Coliseum to pass the torch to a Special Olympics athlete who, in turn, lights the Olympic flame at the Opening Ceremonies of the Special Olympics Iowa State Summer Games.
